ELIGIBILITY CRITERIA

1. The bidder shall be either an Original Equipment Manufacturer (OEM) /Authorised distributors/dealers/reputed organizations/Authorised System Integrator in India. Self Declaration or any document to be submitted.
2. The bidder should have Support Service Center with Manpower in at least five districts (Including Purulia and Bardhaman) of the state of West Bengal, India. So that any call report is attended within the response time. There are 18 districts. The detailed Support Service with manpower should be submitted.
3. The bidder should have executed one single order of similar nature of jobs of Rs. 7 lakhs or more preferably at any Govt. Department / Quasi Govt. Dept / PSU / Board / Council or similar organization in last three financial years. Reference order copies must be submitted.
4. The bidder shall have an annual turnover of not less than Rs.2.00 crore in **each of** last three financial years. **Audited Annual Financial statements need to be submitted.**
5. The bidder should have VAT Registration Certificate and valid Service Tax Registration Certificate. Documentary evidence to be submitted.
6. The bidder shall have **valid** Quality Certificate (ISO 9001:2008).
7. Bidder should submit a declaration on Non Judicial Stamp Paper of Rs.10.00 **duly notarized**, that they have not been debarred / blacklisted by any Government Agencies or any PSU in India during the last three years. The bidder should mention in the declaration that “they have not been debarred / blacklisted by any Government agencies or any PSUs in India during last three years”.
8. Manufacturer’s authorizations for this tender for Server & UPS must be submitted.
9. The OEM should be in a position to ensure service during the warranty period and availability of spares for minimum period of 2 years after the warranty period. OEM should also mention the Life of the machine quoted. Certificate from OEM to be submitted.
10. The bidder should have a Call Centre operational on all days of the year except Sundays & National holidays. Details to be submitted.
11. Bidder should submit Earnest Money Deposit (EMD) **of Rs.1,00,000.00 (Rupees one Lakh only) in the form of Demand Draft from any Scheduled Bank in favour of “Webel Technology Limited”** payable at Kolkata.
