- 2) At each Data Centre, Bidder must provide connectivity till telecommunication room. Further connectivity to SDC Primary & DR Site routers to be provided by the Purchaser. Bidder must ensure that interface for the link from telecommunication room to WBSDC/DR Site routers is either fast ethernet or gigabit ethernet.
- 3) Bidder must ensure media is from own optical fiber end to end that includes service provider's next hop to WBSDC/DR location on either side.
- 4) Bidder should lay fiber as per terms and conditions and within committed time frame specified in SECTION – E, Sl. No. 15, without causing inconvenience or damage to WBSDC/DR Site assets.
- 5) Timeframe for laying of optical fiber NLD backbone from end-to-end (including service provider's link to WBSDC/DR location) shall be Six weeks.
- 6) The Service provider shall provide all the equipment such as mux, modems, converters and any other hardware required to terminate the point-to-point link on Routers at West Bengal State Data Centre & DR Site . The maintenance and ownership of all such equipment, except router on which the required link will be terminated, will be with Service provider only. WTL shall provide power and space for co-locating the termination equipment without any charges.
- 7) The Service provider must specify in the bid the space and power requirements for their equipment. All equipment must have dual input power supply. The Bidder will provide C13/C14 power connectors and all equipment must have suitable cable with C13/C14 connectors.
- 8) The Service provider shall make all arrangements for testing and commissioning of end to end Connectivity.
- 9) Mechanism for logging of complaints related to connectivity /routing problems at any point of time during the 24x7 basis service period including contact details of NOC engineers like telephone numbers, name, e-mail, fax, address etc. shall be submitted to WTL.

30. BANKRUPTCY

43. BID DUE DATE

69. Opening of Bids by WTL

Other than above reports following reports shall be submitted -

- **Interface Availability:** It shall show Availability report having interface daily, weekly, monthly or custom period basis to measure device level and network level availability and ensure that SLA specifications are being met.
- **Interface Traffic statistics:** It shall show Graphs & reports of interface traffic and utilization statistics to analyze network usage and plan for additional

capacity.

- **Interface Response time monitoring:** It shall measure network latency and alert when thresholds are violated by identifying degradations early to ensure optimal Link performance for end-users.
- **Interface errors:** It shall monitor errors and discards on each interface to quickly identify faulty interface and take corrective action.
- **Real time and Historical web-based reports and web-based monitoring through portal should be provided to the Customer.**
- **On-line Portal:** Online portal for viewing bandwidth utilization, uptime/downtime and all other SLA parameters

d. Up gradation of Bandwidth

In the event of operational requirement bandwidth of any location will be upgraded/degrade from the initial contracted value to higher/lower value permanently, at the contracted rate. The customer will place order for the same.

e. Transition Support

During the acceptance test to be conducted by the customer, the Bidder [Service Provider] to provide expert personnel at the site for providing transition support to complete the acceptance testing.

f. Closing down of Office

In the event of closing down of any office, the customer will intimate the vendor in advance. The recurring charges till the end of the running year will be paid by the customer. The contracted unit cost will be reduced before issuing the purchase order for the next year. The required hardware may be collected subsequently.

g. Maintenance Services

The customer has its IT team at its corporate office for monitoring and liasoning with service provider for network related issues. The IT team will be single point of contact with the Bidder [Service Provider] NOC team for all service related issues. The Bidder [Service Provider] has to provide details of one contact person for each location, with whom the customer can follow-up in case of emergencies.

h. Site Preparation and Installation

The Bidder [Service Provider] has to perform site inspection to verify the appropriateness of the sites before installation / commissioning of the network. All cabling should be done with proper clamping. The cabling should be neat and structured with PVC pipe casing.

i. Audit Observations and Compliance

The customer is subjected to various audits [internal / statutory / external etc.]. In the event of any observation by the audit regarding security, access control to routers etc., of WAN the same will be intimated to the Bidder. The Bidder [Service Provider] to assist the customer for compliance of the same.

j. Review meetings

The customer may review and discuss the performance of network fortnightly for the first three months after acceptance. Thereafter review meetings would be held monthly during first week of every month. The Bidder [Service Provider] has to submit Minutes of Meeting after the meeting.

MAINTENANCE LEVEL FOR DEDICATED FIBER

a) Maintenance Levels Committed

“LC” shall put its best effort and ensure the maintenance the availability of dedicated fibre more than 99.5% on monthly basis with the exception of Force Majeure & Planned outages. for the shortfall of availability below 99.5% Service Credit will be provided by “LC” adjusted on half yearly basis failure to comply with the same TTL shall make necessary adjustment against the payment to LC on this account

b) Compensation for Failure to maintain Service Level

- i. Downtime comprising of a continuous break in service maintenance for 1 hour or more shall only be considered. However, Downtime of less than 1 hour shall not be more than 2(Two) times in a month. In the event of downtime of less than 1 hour is more than 2(Two) times in a month all downtime shall be considered as downtime.
- ii. As soon as the uptime falls below this guaranteed level of 99.5%, TTL will be entitled to avail service credits, equivalent to a pre-determined Multiplication Factor of the Downtime [basis of determination].
- iii. $\text{Downtime \%} = (99.50\%) \text{ minus (Actual Uptime \%)}$
- iv. The uptime percentages will be calculated upto two decimal points, e.g. 98.87%.
- v. The downtime will be calculated in days, rounded up to the two decimal points. Each 1% downtime down time is equal to 3.65 days. The pre-determined Multiplication Factors for downtime below 99.5% to arrive at applicable service credits are shown in the Table 1 below. These factors are applicable only for the slab against which they are indicated.
- vi. The Maintenance credits shall be calculated on an annual basis. The maximum service credit for a year available is 28.29 days, which corresponds to service level of 95.00%.

Some representative examples of calculation of the service credits are shown in the notes to Table 1.

- i. As per Table 1 above, each slab of down time has a unique multiplication factor. The Mathematical Equation of the Calculation will be as follows:

Total Maintenance Credit = (99.49 to 99.00 = 0.5 % down time X Factor 0.5)

+

(98.99 to 98.00 = 1 % down time X Factor 1.0)

+

(97.99 to 97.00 = 1% down time X Factor 1.5)

+

(96.99 to 96.00 = 1 % down time X Factor 2.0)

+

(95.99 to 95.00 = 0.5 % down time X Factor 3.0)

- ii. The actual figure of calculation looks like this for the above: 1% of down time = 365 days

= 0.9125 + 3.65 + 5.475 + 7.30 + 10.95 (days)

Total Maintenance Credit = 28.29 days

Exclusions

Down time due to following situations will not be considered for the purpose of penalty calculation

- Schedule maintenance by the service provider with prior intimation
- Force majeure events
- If latency of any link is more than what is specified in SLA for continuous 30minutes during normal business hours then financial penalty would be applicable to the tune of Rs.500/- per hour for higher latency.

MTTR will not be calculated in EBH except for data centre.

MTTR will be allowed only for two downtime events for each location in a month.

As business critical applications will be running on the Customer's Network, any extended downtime as mentioned below will severely affect customer's business causing substantial financial and reputation loss. Therefore, to avoid such losses, the successful bidder should take adequate steps to deliver the desired uptime.

The customer will have periodical review of the availability/performance of links. If the links are down continuously for a longer time or non-fulfillment of various parameters in functioning of links, the customer may terminate the

Other Contractual Obligations of the Successful Bidder

6. The bill of material containing item-wise details in respect of Supply & Maintenance of Bandwidth by the Successful Bidder, must be furnished along with the prices thereof, in the commercial bid and as per the terms and conditions contained in this document.
7. The successful bidder will abide by the job safety, insurance, customs and immigration measures prevalent and the laws in force in India, and will indemnify the Customer against all demands or responsibilities arising from accidents or loss of life, the cause of which is the Successful Bidder's negligence. The Successful Bidder will pay all indemnities arising from such incidents and will not hold the Customer responsible or obligated.
8. The Successful Bidder shall be responsible for, and obligated to conduct all contracted activities with due care and diligence, in accordance with the Contract and using state-of-the-art methods and economic principles, and exercising all reasonable means to achieve the performance specified in the Contract.
9. The Successful Bidder shall work closely with the customer's staff, act within its own authority, and abide by directives issued by the Customer that are consistent with the terms of the Contract.
10. The Successful Bidder shall be responsible for managing the activities
