Applications are hereby invited for Contractual Software Developer, Software Designer and Software Support Personnel on purely temporary and contractual basis **by the 3<sup>rd</sup> Party Agency**. Details of eligibility criteria for applying to the posts are given below:-

1. **Name of the Post for contractual Engagement :** Software Developer ( with PHP, JAVA and .NET background)
  - a) No. of Person/s to be engaged: 03 (Three) Nos.
  - b) For Candidates with PHP Background should possess 3 to 5 years of experience in Core+ PHP Framework (Laravel .8), Node JS, Angular JS, JQuery, Javascript, Mongo DB, MySQL, PHP 7.4 and upper, API knowledge.
  - c) For Candidates with Java background should possess more than 3 years of experiences in STRUTS2, Hibernate, MySQL, Mongo DB, JSP, AJAX, IREPORT, Angular JS, SPRING-BOOT-MICRO Service, flexible with ECLIPSE and NETBEANSIDE.
